ORDER:-

WHEREAS, the Committee of Management of the Pondicherry Carpenters Industrial Co-operative Society Ltd., No. P.307 was superseded and Thiru. C.Saravanane, Senior Inspector was appointed as the Special Officer for a period of six months from the date of assumption of office to manage the affairs of the society vide reference 1st cited. Accordingly Thiru.C.Saravanane has assumed charges as the Special Officer with effect from 10-10-2014.

2. AND WHEREAS, in the reference 2nd cited, the Special Officer of Pondicherry ~~Industrial Co-op. Printing Press Ltd. No. P.200~~ ^{Industrial Co-op. Society} has requested the Registrar of Co-op. Societies to relieve him from the additional charge as Special Officer of the said society for the reasons stated therein.

3. NOW THEREFORE, in exercise of the powers conferred under sub-section (1)(a) of section 83 of the Puducherry Co-operative Societies Act, 1972, I, hereby appoint Thiru. P. Iyyappan, Junior Inspector (Consumer Section) of this Department, as the Special Officer to manage the day to day affairs of the Pondicherry Carpenters Industrial Co-operative Society Ltd., No. P.307 with immediate effect up to 9-10-2015, in addition to his normal duties relieving Thiru.C. Saravanane, Senior Inspector.

The Special Officer shall subject to the control of the Registrar and shall have power to exercise all or any of the functions of the committee or any officer of the society and take all such action as may be required in the interest of the said society. He shall constitute a new committee by election in accordance with the provisions of the Act, the Rules and bye laws of the society before the expiry of his tenure as Special Officer of the Society.
