ORDER

Sub: Transfer and Posting of Senior Inspector of Co-operative Societies – Order – Issued.
Ref: ID Note No.24986/CS(Coop)/A3/2015 dt. 18.08.2015 of the Chief Secretariat (Coop), Puducherry.

Thiru A. Naicker Rajasekar, Senior Inspector of Co-operative Societies, Co-operative Department, Puducherry is transferred on deputation to the Pondicherry State Co-operative Housing Federation Ltd. (HOUSEFED), Puducherry as "Sale Officer", with immediate effect, vice Thiru G. Kamaraj, Senior Inspector, repatriated. He will be on deputation initially for a period of three years with effect from the date of joining or till the necessity therefor ceases whichever is earlier.

2. The terms and conditions of deputation are as stated below:

- i) PAY: During the period of deputation, the incumbent, shall continue to draw his pay and grade pay admissible to him from time to time in his parent department plus deputation allowance, if any at the rate of 5% of basic pay subject to a maximum of Rs.2000/- per month in accordance with and subject to the terms and conditions as communicated by the Department of Personnel and Training, Ministry of Personnel, Public Grievances and Pensions, Government of India in O.M. No.6/8/2009-Estt.(Pay II), dated 17.06.2010.
- ii) DEARNESS ALLOWANCE: He will be entitled to dearness allowance at the rates prevailing in the parent department.
- iii) He will also be entitled to the following allowances as admissible to the employee of the Government of Puducherry and the liability in this regard will be borne by the borrowing Department:
- a) HRA / Transport Allowance.
 - b) Joining Time and Joining Time Pay.
 - c) Travelling Allowances and Transfer T.A.
 - d) Children Education Allowance / Reimbursement of Tuition fees.
 - e) Leave Travel Concession.
- iv) MEDICAL FACILITIES: The medical facilities will be regulated in accordance with the rules of the borrowing organization.
- v) PROVIDENT FUND BENEFITS: During the period of deputation, he will continue to subscribe to the Provident Fund of his parent department to which he is subscribing when he is placed on deputation in accordance with the rules of such funds.

- vi) INSURANCE SCHEME: He will continue to be governed by the Central Government Employees Insurance Scheme 1977 or the Union Territory Employees Group Insurance Scheme, 1984 as the case may be.
- vii) LEAVE AND PENSION: He will be regulated by the Leave and Pension Rules of the parent Department.
- viii) LEAVE SALARY / PENSION CONTRIBUTION: The leave salary contribution (except for the period of leave availed of on foreign service) and pension contribution / CPF (Employer's share) contribution are required to be paid by the borrowing organization.
