Sub: Establishment - Appointment of Tmt. C. Vadivukarasi as Lower Division Clerk - Posting Order - Issued.

In pursuance of the Memorandum cited under reference and on having reported for duty and after verifying all the original certificates & fulfillment of terms and conditions, Tmt. C. Vadivukarasi, W/o. G. Karounakaran is appointed in a temporary post of Lower Division Clerk (Group C) in Pay Level-2 of the Pay Matrix (Pre-revised Scale of Pay of Rs.5200-20200 with Grade Pay of Rs.1900) on regular basis in the Co-operative Department, Puducherry with effect from the fore noon of 10th March, 2022 in the existing vacancy.

2. The terms of appointment are as follows:-

- a) The appointment is temporary and may be terminated at any time by a month's notice given by either side without assigning any reasons. The Appointing Authority, however, reserves the right of terminating the services of the appointee forthwith or before the expiry of the stipulated period of notice by making payment to her of a sum equivalent to the pay and allowances for the period of notice or the unexpired portion thereof. Other conditions of Service will be governed by the relevant rules and orders in force from time to time.
- b) She is placed on probation for a period of two years with effect from 10-03-2022.
- c) She should also work as Cashier if she is so directed by the Head of Department/Office, for which she should furnish necessary Fidelity Bond/Cash Security.
- d) She should pass the prescribed departmental tests viz. Accounts Test for Subordinate Officers (Part-I & Part-II), Common General Departmental Test for Ministerial Staff during the period of probation failing which she will be ousted from service.
- e) On production of a Declaration that she will abide by the Central Administrative Tribunal Order dated 18.06.2019 in O.A. Nos.55, 478, 305, 54, 56, 919, 989, 879, 881 and 878 of 2013, 857 of 2015 and 1946 of 2014 and will not claim any retrospective benefits on her appointment to the post of Lower Division. Her seniority in the cadre of LDC will start from the date of her appointment as per the above said CAT Orders.

3. Her initial pay is fixed @ Rs.19,900/- in the Cell-1 of Level-2 of the Pay Matrix of 7th CPC with effect from 10.03.2022 as per Rule 8 & 10 of CCS (Revised) Pay Rules, 2016 along with other usual allowances at the rates admissible and subject to the conditions laid down in rules and orders governing the grant of such allowances in force from time to time.

4. She has produced necessary Medical Fitness Certificate for Government Service obtained from the Assistant Director (RMO), Indira Gandhi Government Hospital and Post Graduate Institute, Government of Puducherry vide No.21630, dated 10.03.2022.
