WHEREAS a notice was issued to the Pondicherry Government Automobiles Workshop Staff Co-operative Housing Society Ltd., No.P.540 vide reference 1st cited, and in pursuance of sub-section (1) of section 126 of the Puducherry Co-operative Societies Act, 1972, to make its representation as to why the said society should not be wound up, for the reason that the society defunct in nature, since long time and there is no scope either for revival of the society or for its survival, and its activities of the society have virtually come to a grinding halt;

AND WHEREAS, this office has sent periodical reminders to the Administrator of the society and advised to convene the General Body and place the notice vide reference 2nd cited;

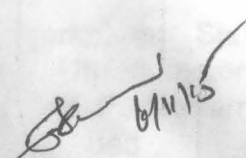
AND WHEREAS, in the instant case lot of opportunities were given to the society;
